Justice L. Narasimha Reddy, Chairman:

The only relief claimed in this OA is that the applicants be extended the relief in terms of order dated 07.09.2009 passed by the CAT, Patna Bench of this Tribunal in OA No.514/2002.

2. In all fairness, learned counsel for the applicants submitted that during the pendency of this OA, the respondents considered the cases of the

applicants in terms of the order of CAT Patna Bench in OA No.514/2002, and passed an order dated 13.10.2015 declining the relief.

3. In view of this development, the OA is disposed of, leaving it open to the applicants to work out the remedies vis-a-vis the order dated 13.10.2015. There shall be no order as to costs.
