Subject : Minutes of the meeting of the Screening Committee held on 11.01.2013 and 14.01.2013 to consider suitability of 23 applicants as per CAT(PB) order passed in OA No.597/2011 filed by Doordarshan Engineering Employees Welfare Association (DEEWA) for grant of 1st ACP benefit introduced by the Govt. vide DOP&T OM dated 09.08.1989.

The meeting of the Screening Committee was convened to consider the suitability of 23 applicants in O.A. No.597/2011 filed by Doordarshan Engineering Employees Welfare Association (DEEWA) in CAT, PB, New Delhi for grant of ACP benefits in terms of the order of CAT, PB, New Delhi in the said OA. The Committee noted that the applicants had sought relief to consider their cases in terms of the benefit of judgment dated 07.9.2009 passed by the Patna Bench of the Tribunal in the O.A. No.514/2002.

2. The Committee was informed that In the order dated 24.5.2011 in O.A. No.597/2011, the CAT(PB) New Delhi (in DEEWA case) has referred to the

following averments made by the the Govt counsel which are recorded in the counter affidavit dated 24.5.2011 and disposed of the O.A. with the directions to the respondents to take necessary steps in the matter as per the averment quoted below:

“ The Hon’ble Tribunal may kindly consider to dispose of this O.A. with direction to the respondents to verify the submissions of the applicants and in the event the applicants are found similarly placed as that of in Patna CAT case, then to extend the same benefits to them as have been extended to the applicants of Patna CAT case.”

3. Based on the information obtained from DG:AIR, regarding date of appointment / promotion to the post of EA, SEA and AE in the pay scales applicable to the these posts in respect of the applicants in the OA and higher / upgraded pay scales granted to them from time to time, the proposal for grant of financial upgradation under the ACP Scheme to raise their pay scale to Rs. 8000-13500/- (pre-revised), as ordered by CAT(PB) was placed before the Screening Committee. The summary of service records in respect of 23 applicants in the OA containing the details of appointment / promotion to the post of EA and SEA in the pay scales applicable to the these posts and higher / upgraded pay scales granted to them from time to time, either in pursuance of the order dated 25-11-1994 passed by the Supreme Court of India or in pursuance of this Ministries OM No. 310/173/97- B(D) dated 05-12-1997 firming up the pay scale of Rs. 5000-8000/- (pre-revised) for the post of EA in AIR & Doordarshan, as granted by the 5th CPC, or in terms of Hon’ble CAT New Delhi order dated 04.01.2001 in O.A. No.1867/1998 resulting in fixation of pay in the revised pay scale of Rs.6500 – 10500 w.e.f. 01/01/1996 was perused.

4. The Committee was informed that a Review Petition has been filed by the UOI and others in the Patna High Court on the ground that the premises on which the judgment of the Hon’ble CAT Patna is based, i.e. the service particulars relating to the pay scales drawn by the applicants in the OA did not match with the submissions of the applicants in the OA in Patna case. The order of CAT Patna was implemented in r/o the applicants in view of the imminent contempt proceedings. The benefits granted to the applicants were subjected to the outcome of this Review Application and other legal proceedings that may be initiated.

5. In the order dated 21.12.2012 passed in C.P. No.710/2011 filed by DEEWA in O.A. No.597/2011, it has been directed to follow the same procedure as has been followed while screening the cases of applicants in Patna Bench case. In view of

this, the Screening Committee decided to consider the applicants in DEEWA case based on the same criteria followed for implementing the CAT, Patna order. The Screening Committee further noted that the scale of pay of Rs.8000 -13,500 was granted to those applicants (in Patna case) who had completed 12 years in the pre-revised scale of Rs.6500-10,500. Further, the benefit was not granted in respect of those applicants whose pay was never fixed in the pay scale of Rs.6500-10500 during their service period.

5. The Committee observed that in respect of the following 7 applicants, there were certain discrepancies in the entries in the service Book. In view of this, the Screening Committee desired that their cases may be put up to the Committee only after correction / confirmation of the pay particulars recorded in the service book. In respect of the remaining remaining 16 applicants in the OA, the Screening Committee after perusal of the ACRs for the relevant period assessed as FIT for grant of financial upgradation under the ACP Scheme to raise their pay scale to Rs. 8000-13500/- (pre-revised) w.e.f 1.1.2008 as per details annexed.




