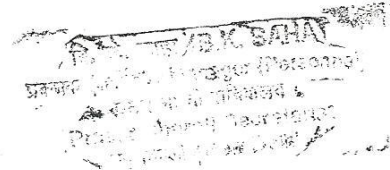

The old circular defining tenure at various stations has become outdated, as with the availability of new facilities, the criteria of place for hardship has changed. Accordingly, it has been decided that a committee consisting of Sr. GM(P), DG, AIR and DG, Doordarshan should meet and suggest guidelines for adoption of transfer policy for smooth functioning of Prasar Bharati.

2. The fundamental principle governing the transfer shall be that the transfer policy must give justice to all employees and no employee should be seen as a favoured category by providing long tenure at his/her choice place.
3. A transfer is an exigency of service and all officers and employees should be prepared to serve wherever required.
4. Under no circumstances should an employee enjoy extended tenure at sought after locations by simply shifting post from one to another when vital field installations remain vacant leading to deficient service.
5. The above Committee should suggest a policy keeping the fundamental provisions within a month. The Office Order No. 116/2011-PPC dated 02.09.2011 be kept in abeyance till the new policy is finalized. However, routine transfers of employees in public interest may continue.
