OFFICE MEMORANDUM

Subject:- Posting of physically Handicapped Candidates.

The undersigned is directed to say that a suggestion has been made that physically handicapped candidates appointed under the Government should preferably be posted in their native places or at least in their native district. The matter has been examined carefully. It may not be possible or desirable to lay down that physically handicapped employees belonging to Group-A or Group-B who have all India transfer liability should be posted near their native places. However, in the case of holders of Group-C or Group-D posts who have been recruited on regional basis and who are physically handicapped, such persons may be given posting, as far as possible, subject to administrative constraints, near their native places within the region.

2. Requests from physically handicapped employees for transfer to or near their native places may also be given preference.
3. Suitable instructions may also be issued to all subordinate u.

विषय:- शारीरिक रूप से विकलांग व्यक्तियों की तैनाती ।

मुझे यह कहने का निदेश हुआ है कि यह सुझाव दिया गया है कि सरकार के अधीन नियुक्त शारीरिक रूप से विकलांग व्यक्तियों की उनके मूल निवास स्थान के आसपास या कम से कम उनके मूल जिले में नियुक्ति करने को प्राथमिकता दी जानी चाहिए । इस मामले पर ध्यान्मूर्क विचार किया गया है । यह सम्भव या वाछनीय नहीं होगा कि शारीरिक रूप से विकलांग समूह-क अथवा समूह-घ के ऐसे कर्मचारियों की जिम्की सेवाएं अछि भारतीय स्थानांतरण दायित्व की हैं उन्हें अपने मूल निवास के निकट तैनात किया जाए । तथापि क्षेत्रीय आधार पर भर्ती किए गए समूह-क अथवा समूह-घ के पदधारियों को जो शारीरिक रूप से विकलांग हैं यथासम्भव प्रशासनिक प्रतिबंधों के अधीन उनके क्षेत्र के भीतर उनके मूल निवास स्थान पर नियुक्त किया जा सकता है ।

2. शारीरिक रूप से विकलांग व्यक्तियों द्वारा अपने मूल निवास स्थान में अथवा उनके निकट स्थानांतरण किए जाने के अनुरोध को प्राथमिकता दी जानी चाहिए ।

3. अभी अधीनस्थ एजकों को भी उचित निदेश जारी कर दिए जाए ।
