Directorate has received references from several Doordarshan Offices seeking clarification regarding admissibility of benefits under FR 22 (1) (a) (i) in fixation of pay in the revised scales on promotion from Engineering Assistant to Senior Engineering Assistant.

- 2. In a discussion held with Shri S.K. Garg, Under Secretary, Ministry of I&B regarding pay related matters of Engineering officials, it was expressed by the Ministry that the pay has to be fixed strictly as per the orders / clarifications/ instructions issued by Ministry of I&B in this regard which is very clear and with no ambiguity. Further it was expressed by the Ministry to fix responsibility for wrong fixation of pay.
- 2. As per the clarifications issued by Ministry of I&B vide their OM No. 310/46/95-B(D) dated 07.06.1996, Where an EA is appointed to the post of SEA no benefit under FR-22(1)(a)(i) admissible. Further, Ministry of I&B's order No. 310/50/99-B(D)/BA(E) dated 10.06.2002 did not recommend application of FR22 (1) (a) (i) and all pay fixation would be as per Ministry of I&B vide their OM No. 310/46/95-B(D) dated 07.06.1996.

Consequent upon isse of this Ministry's letter No.310/15/93-B(D) dated 15th May, 1995 on the subject noted above, Ministry has been receiving communications from DG:ATR and DG:Doordarshan from time to time seeking clarifications on various points relating to fixation of pay of Engineering A ssistants and abov e w.e.f. 1.1.78/1.1.86. The matter has, therefore, been examined at length in consultation with Chief Controller of Accounts and it has been decided that pay fixation cases covered by the instructions contained in this Ministry's letter dated 15th May, 1995 referred to above, may be dealt as under:

- 1. Where the pay drawn by an EA in the old scale is lower than the minimum of the new scale.
- Minimum of the new scale of pay on the crucial date. Next increment will be drawn after completion of full incremental period at that stage from the date of fixa-tion of initial pay in the revised scale. (Order 6 below FR-23)
- 2. Where the pay drawn by an EA in the old scale is equal to the minimum. of the new scale.
- At the minimum in the new scale. Next increment will be drawn on thedate of increment in old scale. (Order 6 below FR-23)
- 3. Where the pay drawn by equal to a stage in the new scale.

At the equal stage in the an EA in the old scale is scale. Next increment will be drawn on the date of increment in the old scale (order 6 below FR-23)

4. Where there is no stage in the new scale equal to the pay drawn by an EA in the old scale. At the lower stage in the new scale and the difference will be allowed as personal pay to be absorbed in future increases in pay. Next increment will be drawn on the date of increment in the old scale or in the new scale, whichever is earlier. (Order 6 below FR-2)

 Availability of option to BAs. There is provision for exercising option to retain old pay until next or any subsequent increment is earned in the old scale. (Provision to FR-23)

 Where an EA is appointed to the post of SEA. No benefit under FR-22(1)
(a)(i) admissible as per advice of DP&T dated 16th April, 1996.

 Where an EA is appointed to the post of AE. Pay shall be fixed in the time scale of AE at the stage next above the notional pay arrived at by adding an increment to the existing pay in the scale of SEA. (FR-22 (I) (a) (1)). Next increment will be drawn on completion of full incremental period of 12 months in the time-scale of the AE.

Incidentally, it is observed from Doordarshan Kendra, Nagpur letter No.NAG/TV/20(3)/95-S/98 dated 12.1.96 (addressed to DG:AIR and copy endorsed to DG:DD among others) that some of the Doordarshan Kendras, like Bhopal, had fixed the pay of EAs in the scale of 5.550-900 w.s.T. 1.1.73 instead of 1.1.78 on the analogy of the judgement in the case of Sound Recordists. It is further observed that Doordarshan Kendra, Nagjur had also done so in the case of Shri J.M. Vishwakarma (now AE), vide order No. NAG/TV/20(2)/95-S/1363 dated 16.11.95.

As per court orders, the scale of EAs has been revised with effect from 1.1.78. It is fundamentally incorrect to extend any other analogies to the instant case and revise the scale from 1.1.73.

 DG:ALL India Radio, etc. are accordingly requested to review all these pay fixation cases urgently and take remedial action for effecting recoveries wherever necessary.

Gonsequent upon issue of this Ministry's O.M. No. 310/46/95-B(D) dated 7.6.96 on the subject mentioned above. Ministry have been receiving representations from Associations/employees seeking distributions on the various points relating to fixation of pay scale of EA w.e.f. 1.1.78/1.1.86.

The issues raised have been examined in consultation with GCA and the following clarifications are hereby furnished:-

Nhere pay is fixed at the minimum of the revised scale of pay, the next increment in the revised pay scale is to be drawn on the normal date of increment in the old scale. This rulling is upheld by the Supreme Court of India in its judgement dated 21.1.91 (Case No. 7 of chapter 13 - Pay 4 Allowances pages 116-117 of Swany's Case Law Digest Vol.17 (1991).

Ministry of Finance have not amended existing rules in oursuance of the judgement. In such cases only the appellant would get the benefit of the judgement.

Nhere there is no stage in the new scale, the pay is fixed at the stage next higher in the new scale. This rulling came into effect on 1.1.86 vide GDI Order No. 26(2) (1) below FR-

1.1.

The pay is to be fixed at the stage next higher in the new scale in case of fixation w.e.f. 1.1.86 and after-wards. In case of pay fixation prior to 1.1.86, however, GIU(b) under FR-23 will apply.

may be fixed without allowing the benefit under FR-22(1)(a)(i) till a final view is taken in consultation with DP%F. However, no refixation or recoveries may be effected, for the time being, in cases where pay has already been fixed by giving this benefit.

1. Pay of EA/SEA as on 1.1.86 may of fixed from Rs. 550-900 (old) to Rs. 2000-3200 (revised) with the application of CCS (Revised Pay) Rules, 1986.

Ho recovery of OTA/Bonus etc. should be effected from the arrears of pay consequent upon revision of pay scale of EA.

The Ministry have, vide Me.no of even no. orders 19.6.96 issued DG: ALR/DG:DD asking in re-fixation indulge to offect or exercises in cases where recoveries pay has already been fixed by giving benefit under FR-22(1)(a)(i) till the matter is decided in consultation DOPS T. As regards with fresh cases, fixation may be done without allowing benefit of FR-22(1)(a)(1)till a final view is taken by DOPET.

It is implied that the pay as on 1.1.86 is to be fixed in accordance with the CCS (Revised Pay) Rules, 1986.

recovered as per interim orders of CAF, P. Bench CAF, New Delhi dated 13.12.95 till this matter is decided in consultations with Ministry of Finance/DOPyF.

Income-tax relief may be computed by DDOs on arrears of pay according to the provision of Section 89(1), 192(2A) and Rules 21A.

The Heads of offices and PAO(IRLA) may give the benefit as laid down in the Income Las Act, 1961 provided the officers concerned furnish requisite particulars.
