Subject: Grant of Grade Pay of Rs 5400 in PB-2 to the Assistant Engineers of AIR & Doordarshan, on non-functional basis, after 4 years of regular service in the grade pay of Rs 4800. –regarding.

Madam,

This has reference to our short discussion in the matter on 07. 01. 2008. We sincerely thank you for kindly clarifying and issuing order dated 29.12.2008 (copy enclosed) granting corresponding Grade Pay of Rs 4800 to the Assistant Engineers of AIR & Doordarshan who were in the pre-revised pay scale of Rs 7500-250-12000 with effect from 01.01.1996. This has saved the AE's cadre from great embarrassment besides reducing the accounts work at PAO offices and Kendras from mass re-fixation of pay and drawl of arrears.

Madam, vide our earlier representation dated 25.11.2008, we have at para.(5), also requested you to kindly grant Grade Pay of **Rs 5400 in PB-2 on non-functional basis** to those Assistant Engineers of AIR & Doordarshan who have completed 4 years of regular service in the grade pay of Rs 4800 (the grade pay corresponding to the pre-revised pay scale of Rs 7500-250-12000) in accordance with the recommendations of 6th CPC and accepted by the government vide **para. 1(x)** of the Government's Resolution dated 29.08.2008 in respect of **Group 'B' cadres** carrying grade pay of Rs 4800. Vide said **para. 1(x)** of the Resolution, while few specific categories of Gr 'B' posts in the Grade Pay of Rs 4800 have been granted Grade Pay of **Rs 5400 in PB-3**, the rest of Gr 'B' posts in various departments with Grade Pay of Rs 4800 are granted Grade Pay of **Rs 5400 in PB-2** on non-functional basis after 4 years of regular service in the grade.

Madam, we therefore request you to kindly issue order to PAO (IRLA) in this regard to grant Grade Pay of **Rs 5400 in PB-2** to eligible Assistant Engineers of AIR & Doordarshan having 4 years of regular service in the grade.
