*Sub:* Circulation of illegal Eligibility List of Assistant Engineers as on 01.01.2006 by the DG:AIR for promotion to JTS cadre of IBES.

**Ref:** DG:AIR's letter no. 4/19/2006-SIV(B), dated 26.10.2006 on the subject.

Sir,

The Directorate General, All India Radio, vide their said letter dated 26.10.2006, has circulated **final eligibility list of 546 Assistant Engineers working in AIR & Doordarshan as on 01.01.2006** for promotion to the JTS cadre of IBES against 50% quota of *seniority-cum-fitness* in the JTS cadre on the basis of recommendations of Departmental Promotion Committees. Contrary to the fact that the eligibility list of Assistant Engineers as on 01.01.2006 should include the names of only those Assistant Engineers who possess qualifications prescribed for Direct Recruit JTS of IBES and have completed 3 years of regular service in the grade of Assistant Engineer, the eligibility list includes many names who do not possess requisite qualification.

Sir, the qualification of Direct Recruit JTS is that which is prescribed by the UPSC for admission to the Indian Engineering Services which includes minimum B.E./B.Tech. degree or equivalent from a recognized University/Institution, or M.Sc. Degree or its equivalent with *Wireless Communication, Electronics, Radio Physics or Radio Engineering as a special subject*. However, the names of a large number of those Assistant Engineers have also been included in the said eligibility list who possess degrees like M.Sc.(Physics), M.Sc.(X-Ray), M.Sc.(Solid State), M.Sc.(Spectroscopy), M.Sc.(Applied Physics), M.Sc.(Education Physics), B.Sc.(Information System), B.Tech. (Information Technology) and Master in Computer Application (MCA) which are not prescribed by the UPSC for admission to IES examinations. It is clearly specified in the UPSC's notification that those who possess M.Sc. (Physics) degree are eligible for admission to the IES examinations only if they have *Wireless Communication*,

**Electronics, Radio Physics or Radio Engineering as a special subject in their M.Sc. degree.** A list of 48 such ineligible Assistant Engineers whose names appear in the final eligibility list as drawn is given hereunder for reference.

List of 48 Assistant Engineers who do not possess M.Sc. (Physics) degree with Wireless Communication, Electronics, Radio Physics or Radio Engineering as a special subject in their M.Sc. degree, but their names have figured in the Final Eligibility List circulated by DG:AIR

Sir, it is understood that the DG:AIR is in the process of holding DPC for filling of 287 vacancies of JTS against 50% quota of *seniority-cum-fitness* based on this illegal Eligibility List. It would not only be an illegal act, but also injustice to those eligible Assistant Engineers who will be deprived of promotion at the cost of those who are ineligible for promotion because of not possessing requisite educational qualifications.

I hereby request you to kindly intervene in the matter to avoid illegal promotions of ineligible candidates and to protect the interest of eligible candidates having prescribed qualifications and satisfying eligibility conditions. We would also like to have personal hearing in the matter to clear any doubts.
