Sub: Circulation of year-wise "Eligibility Lists" of Assistant Engineers of AIR & Doordarshan for promotion to JTS cadre of IB(E)S in accordance with the IB(E)S(Amendment) Rules, 2008. –Regarding.

Sir,

There has been persistent demand from Diploma/B.Sc. degree holder Assistant Engineers for amendment of IB(E)S Rules to allay retrograde qualification bar in promotion from AE to JTS cadre, imposed on 23.03.1989 through IB(E)S(Amendment) Rules 1989, which followed setting up of a number of High Level Departmental Review Committees by the DG:AIR and also filing of numerous suits in court of law by the individuals. It has been matter of great satisfaction that the Ministry of I&B has amended the Indian Broadcasting (Engineers) Service Rules, 1981 through Gazette Notification dated 18.03.2008 (copy enclosed) which has now removed the discrimination in promotion of Assistant Engineers of AIR & Doordarshan on the basis of their academic qualifications. The restoration of justice (**pre 23.03.1989 status**) to the Diploma & B.Sc. degree holder Assistant Engineers in their promotion to JTS of IBES through this notification dated 18.03.2008 is in honest compliance and true spirit of judgments of Hon'ble Supreme Court of India, dated 05.12.2003 and Cuttack Bench of CAT, dated 22.03.2004 in the matter which will go a long way in removing severe stagnation and frustration in whole AE cadre of AIR & Doordarshan.

The latest Eligibility List of 528 Assistant Engineers of AIR & Doordarshan for their promotion to JTS cadre of IB(E)S, which has been circulated by DG:AIR vide File No. 4/23/2006-S.IV(B)/ pt , dated 27.04.2009, pertains to as on 01.01.2007 which is based on IB(E)S(Amendment) Rules, 1989. Thereafter, no eligibility list has come out.

Now, consequent upon latest amendment of IB(E)S Rules vide **IB(E)S(Amendment) Rules**, 2008 which came in force on **18.03.2008**, the vacancies arising out in the JTS cadre with effect from **18.03.2008** onwards shall obviously be filled under the provisions of **Indian Broadcasting** (Engineers) Service (Amendment) Rules, 2008.

It is therefore requested that the pending Eligibility Lists of Assistant Engineers as on 01.01.2008 (under the old rules) and as on 18.03.2008, 01.01.2009 and 01.01.2010 (under the new IB(E)S(Amendment) Rules, 2008) for their promotion to JTS cadre of IB(E)S may kindly be circulated at the earliest.

It is also mentioned here that the Ministry of I&B has already issued instructions vide Letter No. 503/15/2008-BA(E), dated 31.03.2010 for sending of revised eligibility lists of AEs to convene DPC of JTS grade of IB(E)S.
