3. The applicants are Engineering Assistants and filed the present O.A. seeking the following relief(s):

- (i) Direct the respondents to grant the scale of Group 'C' highly skilled carpenter w.e.f. the implementation of 6th CPC;
- (ii) Award the cost of litigation;
- (iii) May also pass any further order(s), direction(s) as be deemed just and proper to meet the ends of justice.

4. It is submitted that the applicants made number of representations to the respondents ventilating their grievances and latest representations are filed as Annexure A/1 colly. However, the respondents have not passed any orders thereon till date.
