Kindly refer to M/o I&B Letter No. V-11013/07/2021-BAE dated 06.10.2022(copy enclosed) wherein instructions have been issued to implement Hon'ble CAT, PB, New Delhi order dated 05.07.2022 in OA no. 100/2691/2021 filed by Sh. Bhanwar Lal Rawal & Ors Vs UoI regarding grant of final pensionary benefits to the retiring/retired government servants.

2. Further, M/o I&B vide its above mentioned Letter dated 06.10.2022 has stated that before releasing the final pension and all pensionary benefits to the retiring/retired government servants, an undertaking may be taken from them that *if any excess payment is made to an individual, then the same shall be recovered from him or her after the disposal of the WP No. 9890/2019 pending before the Hon'ble high Court or any other similar litigation.*

3. In view of above, as intimated vide M/o I&B Letter dated 06.10.2022, all PAOs are instructed to strictly implement the instructions issued by M/o vide Letter no. V-11013/07/2021-BAE dated 06.10.2022.
