## ORDER (ORAL)

## Mr. V. Ajay Kumar, Member (J) :-

With the consent of the counsels, the main OA itself is taken up for hearing, since the subject matter of the OA is squarely covered by the order of this Tribunal in OA No.1118/2015 (Smt. Syamali Biswas Vs. UOI & Ors.)

2. It is also submitted that the respondents questioned the said order by filing the Writ Petition (Civil) No.2034/2017, whereunder the Hon'ble High Court of Delhi by its interim order dated 11.04.2017 passed the following order:-

"Issue notice to the respondents, returnable on 10thAugust, 2017.

Learned counsel for the petitioner submits that the respondent became an employee of Prasar Bharti on 1stNovember, 1997 and had retired also from the same institution. With reference to MACP scheme, it is submitted that the respondent was initially appointed as Engineering Assistant in the pay-scale of

Rs.5000-8000, has earned more than three financial upgradations. As per the MACP Scheme, the next higher grade pay is payable.

There will be stay of the operation of the impugned order till the next date of hearing.

Relist on 10th August, 2017."

- 3. In view of the above referred submissions, the instant OA is also disposed of in terms of the judgment of this Tribunal in OA No.1118/2015 dated 31.03.2016. However, the same is subject to the orders passed in Writ Petition No.2034/2017.
- 4. The pending MA also stands disposed of.
