ORDER

The following orders of Hon'ble CAT, Principal Bench, New Delhi, in various cases, regarding grant of grade pay of Rs. 5400/- in PB-2 on non-functional basis after completing four years of regular service in Grade Pay of Rs. 4800/- in PB-2, were under consideration of this Directorate for compliance:

- 2. The Ministry of I&B vide their letter No. 515/50/2015-BA-E dated 2/9/2016 has conveyed the approval of Department of Expenditure, Ministry of Finance, to grant the Grade Pay of Rs. 5400/- to the applicants of the above mentioned OAs. The applicants in the aforesaid OAs are similarly situated with the cases of Sh. R.K. Jain (OA No. 2662/2009) and Sh. B.P. Dhaman (OA No. 3048/2012). Accordingly Non Functional Grade Pay of Rs. 5400/- is granted to the eligible applicants, who have completed 4 years of regular service in Grade Pay of Rs. 4800/-, as per the following conditions:
 - (i) Grant of the higher grade pay of Rs. 5400/- in PB-2 on non-functional basis is not linked to vacancy and may be given retrospectively w.e.f. 1/1/2006 or on completion of 4 years of regular service in the grade of Assistant Engineer with Grade Pay of Rs. 4800/-, whichever is later, provided they are clear from vigilance angle.
 - (ii) The non-functional Grade Pay of Rs. 5400/- in PB-2 will not be granted to such Group 'B' officers who have got the Grade Pay of Rs. 4800/- on up-gradation under the MACP Scheme.
 - (iii) As per directions of the Ministry of I&B vide letter No. 515/86/2015-BA-E dated 21/1/2016 (copy enclosed), the applicants in above OAs will submit an undertaking that they were not applicants in any court case relating to grant of ACP either pending or disposed of.
