Subject: Grant of ACP to similarly situated EAs, SEAs, AEs as per the verdict in OA No.514/2002 - Constitution of Screening Committees-regarding.

Reference is invited to this Directorate's letter of even No. dated 15.07.2015 regarding constitution of Screening Committees headed by the respective zonal ADG(E)s for scrutiny of the service records of all eligible EAs, SEAs, AEs and to send proposals in the prescribed proforma to this Directorate for grant of ACP as per the verdict in OA No.514/2002.

- 2. In the above context, it is clarified that point no. (v) & (vi) of para 3 of the letter cited above may be ignored while examining the service records. Also no information need to be furnished regarding ACR grading and vigilance clearance of AEs. These details will be filled by this Directorate after all other service details are examined and certified by the Screening Committees from the service records (service books) of all EAs, SEAs and AEs in the prescribed proforma. Proposals for grant of ACP may be submitted separately for EAs, SEAs and AEs, duly signed by all members of the Screening Committee. Stations/Kendras may be advised not to send any proposals directly to this Directorate.
- 3. All Zonal ADG(E)s are requested to submit their recommendations to this Directorate as early as possible in view of the large number of court cases including contempt of court cases. This issues with the approval of Competent Authority.
