Subject: Clarification regarding pay fixation of JTS Officers of IB(E)S

The undersigned is directed to invite reference to DG:AIR's communication bearing No. 8/1/2018-S.III/225 dated 29.03.2019 on the above subject addressed to MIB and a copy endorsed to PB Sectt.


2. The matter has also been examined in Prasar Bharati Secretariat by taking reference from the exactly similar case of Income Tax Officers in the Directorate of Income Tax, Central Board of Direct Taxes, Ministry of Finance.

3. The scale of PB 2, GP Rs. 5400/- of Assistant Engineers is Non Functional Scale granted on completion of 4 years of regular service in PB-2, GP Rs. 4800/- and is similar to Non-Functional Scale granted to Income Tax officers of Income Tax Department. The grant of Non-Functional scale to Assistant Engineers is neither similar to MACP nor Non Functional Upgradation (NFU) granted to the officers of organized Group A Services as MACP or NFU are granted to eligible officers in lieu of promotion.

4. Accordingly, the pay of Assistant Engineers, who have been granted Non-Functional Scale in PB-2, GP Rs. 5400/-, on promotion to Assistant Director (Engineering) in pre-revised pay scale of PB-3, Grade Pay Rs. 5400/- is to be fixed as per clause 13(i) of the Gazette Notification dated 25.07.2016 issued by Ministry of Finance which reads as under"-

"One increment shall be given in the level from which the employee is promoted and he shall be placed at a cell equal to the figure so arrived at in the level of the post to which promoted and if no such cell is available in the Level to which promoted, he shall be placed at the next higher cell in that level".

5. This issues with the approval of CEO, Prasar Bharati.
