In pursuance of DOP&T, GM No.35034/3/2008-Ext.(D) dated 10<sup>th</sup> May, 2004, the Competent Authority has approved the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> financial up-gradation on completion of 10, 20 and 30 years of regular service in the grade in respect of the 228 TREXs/ESAs under the MACP Scheme as per Annexure-I.

2. Prasar Bharati Secretariat has already taken up the matter regarding admissibility of MACP to TREXs and some other cadres with the Ministry of I & B. It has therefore been decided to grant MACPS benefits subject to outcome of the clarifications from the Ministry of I & B/Prasar Bharati Secretariat. The MACP benefits are liable to be revised/recovered without pre-notice in respect of these incumbents and all those already granted if it is decided to do so by the Ministry of I & B/Prasar Bharati Secretariat.

3. Head of all Stations/Kendras/Offices of AIR/DDK are requested to check the service particulars/regularly statement/Vigilance clearance in respect of these employees well before their pay fixation. The Direct Recruit TREXs may be given GP- ₹ 1500/- PB-2, ₹ 5,000/- PB-2 & ₹ 5400/- PB-3 as 1<sup>st</sup>, 2<sup>nd</sup> & 3<sup>rd</sup> financial up-gradation under the MACP Scheme respectively. Whereas Grade Pay & effective date in respect of promoted TREXs would be subject to adjustment of previous promotions/ACPs/MACPs granted. Head of all Stations/Kendras/Offices of concerned AIR/DDK may verify the service particulars etc of TREXs scrupulously in case of any doubt refer the matter to this Directorate for clarification before the pay fixation.

4. The above-mentioned financial up-gradation is purely personal to the employee concerned and shall have no relevance to his/her seniority position. Further, this financial up-gradation is subject to the relevant instructions/orders on MACPS issued from time-to-time.

5. The above pay fixation is subject to post audit and in the light of audit observation over-payment, if any, shall be recovered from them in lump-sum.

6. The order in respect of rest of the eligible TREXs/ESAs and Hindi version will follow.
