Please refer to this Sectt.'s letter of even number dated 7th / 9th October, 2014 forwarding therewith a copy of letter No.G-11502/Pr.AO/Circular/2013-14/2051 dated 23rd September, 2014 received from Pr. Accounts Office, Ministry of I&B together with its enclosure (i.e a copy of letter No.503/5/2014-BA(E) dated 08.09.2014 with an attached note of DOP&T from Smt. Harcharan Kaur, Deputy Secretary, Ministry of I&B addressed to the Chief Executive Officer, Prasar Bharati) on the above subject for information, guidance and strict compliance.

In this regard, kind attention is invited to this Sectt.'s earlier letter No.PB-4(3)/2013-Admn. dated 12.11.2014 indicating the decision taken by Prasar Bharati Board on the issue of granting MACP to the employees of Prasar Bharati in general and 11 categories of Employees contained in MIB 's OM dated 25.02.1999 in particular. Since, the stand taken now by the Govt. (DOP&T), as conveyed vide MIB's letter dated 08.09.2014 was found to be contrary to the conscious decision of the Prasar Bharati Board, the Prasar Bharati has moved a proposal to the Ministry re-iterating Board's decision on the matter.

In view of the above, it has been decided by the Competent Authority in Prasar Bharati to withdraw this Sectt.'s letter dated 07/09.10.2014 cited above forthwith and stop operation of the decision contained in MIB's letter dated 08.09.2014 by all the PAOs till specific orders are issued by Prasar Bharati on this issue.

All the PAOs of Prasar Bharati and Non-Prasar Bharati PAOs are hereby advised to take note of the above decision of Prasar Bharati for appropriate action accordingly.
