Sub: Strict Compliance of Hon'ble CAT (PB) & Ministry of I&B's Orders for Release of Regular Pension to Retiring/Retired Employees- reg.

Madam/Sir,

Reference is invited to (i) this office letter dated 17.10.2022 in light of BAE Section, Ministry of I&B's letter dated 6.10.2022 for compliance of Hon'ble CAT, Principal Bench Order dated 5.07.2022 and (ii) this office letter dated 23.12.2022 in light of BAE Section, Ministry of I&B's letter dated 16.12.2022 for compliance of Hon'ble CAT, Principal Bench Order dated 5.07.2022.

In this context, it has come to notice that some PAOs under Prasar Bharati are not adhering to the instructions issued by O/o ADG (B&A), Prasar Bharati vide ibid letters dated 17.10.2022 & 23.12.2022 for (i) release of regular pension instead of provisional pension to all retiring/retired government servants after obtaining undertaking from them and (ii) not counting promotion from EA to SEA as up-gradation under MACP till final conclusion of court matter.

It is reiterated that since the matter is sub-judice in various CATs and High Courts, as a measure of interim relief to the retired/retiring employees, Ministry of I&B has instructed to release regular pension instead of provisional pension to all the employees till further orders after obtaining undertaking from them. Henceforth, no further clarification or approval is required in this matter.

All PAOs & Sr. AO, Pay fixation Cell/CDN are, therefore, requested to strictly adhere to the orders issued by Hon'ble CAT, Principal Bench and Ministry of I&B and avoid contempt of court and any further grievances.

This issues with the approval of ADG (B&A), Prasar Bharati.
